- Any donation of securities received after 5 p.m. on December 10th of that year will be processed on a best-efforts basis.
- If the donor would like to donate physical “certificates,” The Sunshine Foundation of Canada must provide written approval of acceptance of delivery of these shares and the certificate must be delivered to RBC PH&N Investment Counsel at the address above in person and signed in front of a staff member.
- Upon receiving this transfer, RBC PH&N IC will contact The Sunshine Foundation of Canada and will advise of the details of the transfer. The Sunshine Foundation of Canada will contact the donor and issue a tax receipt.

Value of Donated Securities

Your gift of publicly traded securities will be valued for receipting purposes at the close of date market value on the day the security is received in The Sunshine Foundation of Canada’s brokerage account. Although donated securities are normally sold the same day they are received, there may still be a small fluctuation in value due to the difference between receipt and sale times. This in no way affects the value you will be able to claim on your tax return, which will be the value shown on your donation receipt.
